



## Information on Processing of Personal Data

Pursuant to a concluded agreement on the processing of personal data, the administrator of your personal data is the administrator of the website [TSR-swimrun.com](https://www.TSR-swimrun.com), domiciled in Stockholm, Sweden, email: [TSR@TSR-swimrun.com](mailto:TSR@TSR-swimrun.com)

Agreement on the processing of personal data, among other things, determines the responsibilities of the administrators for fulfilling their obligations under the General Data Protection Regulation GDPR - EU Regulation 2016/679 ("the Regulation"). Your personal data is obtained by the administrator through various race websites which must also fulfill their obligations under the Regulation.

### What Personal Data We Process

The administrator processes the following personal data of yours: first name, last name, name of the races you finished, gender as category of the team with which you finished a race, your finisher's position in the category, your TSR individual ranking, your TSR team ranking, your TSR points, email, marketing preferences. As the administrator, we do not process any personal data classified as special personal data.

### What is the Purpose of Processing Your Data

Your personal data is processed in accordance with applicable law of personal data protection in connection with swimrun events. Data administrators process your personal information for the following purposes:

- Assigning points to athletes' performances
- Ranking athletes
- Administrating user accounts
- Analyzing performance data
- Sending information and offers

### What is the Purpose of Processing Your Data

Regarding individual categories of personal data and the purposes of its processing, your personal data is processed on the basis of the following legal bases:

- the legitimate interest of the data administrator: first name, last name, name of the races you finished, category of the team with which you finished a race, your finisher's position in the category, your TSR individual ranking, your TSR team ranking, your TSR points

- consent to the processing of personal data: email and marketing preferences

## Where We Collect Your Personal Data

Your personal data is collected directly from the swimrun race websites where you registered your data and/or from your own registration to the TSR-swimrun.com website.

## What Are Your Rights Under the Regulation?

### *Right to Access Your Personal Data*

As the Data Administrators, we are obliged to provide you with all information about your personal data that we process, how we process it, on what legal basis we process this data, who we provide it to, and how long we will process it.

### *Right to Correction of Your Personal Data*

In the event of a change in your personal data, or if some of your data are inaccurate or incomplete, you have the right to correct the data.

### *Right to Deletion of Your Personal Data*

As an individual, you have the right to request the deletion or correction of your personal data if any of the following conditions are met:

- Personal data is no longer needed for the purpose for which it was originally acquired and then processed
- if you withdraw your consent to processing that was based on your consent and there is no other legal reason for processing
- Your objection to data processing based on the legitimate interests of the Administrator is well founded and correct
- Processing your personal data has been in contravention of the Regulation
- Parental consent to the processing of personal data of children under 15 years of age has not been granted

### *Right to Limit Processing*

Processing of your data will be suspended in the case of legitimate use of this right, and if one of the following conditions is met:

- Until we verify your data, which has been questioned by you
- The processing does not have a legal basis, your choice is, however, to limit the processing before the complete deletion of your personal data
- We no longer use your personal data as the Administrators, however you require the personal data for identification, exercising or defending legal claims

### *Right to Data Transferability*

Based on this right, you may, upon your own request, obtain personal data about you in a structured form for its forwarding to another administrator. In this way, we may provide you with the personal data you have provided to us. Processing of this personal data is

based on the given consent or the performance of contract, and if the processing is done by automated means.

### *Right to Objection*

Your right is to object to the processing of your personal data on the basis of our legitimate interest or performance of a public interest task, the processing of personal data for direct marketing and processing for the purpose of scientific or historical research or statistics.

### *Right Related to Automated Processing*

You have the right not to be the subject of a decision based exclusively on automated processing, for example on age, residency or nationality.

In order to exercise your rights, you can writing to the personal data administrator electronically to [TSR@TSR-swimrun.com](mailto:TSR@TSR-swimrun.com).

If you believe that your personal data has been processed in violation of the Regulation, it is your right to file a complaint with the Supervisory Authority.

It is not your responsibility to provide personal information, but your personal information is a prerequisite for registering to the race. In such a case it is possible to create a user account and to register without providing consent.

You have the right to withdraw any consent you have given us. You can withdraw your consent by writing to [TSR@TSR-swimrun.com](mailto:TSR@TSR-swimrun.com).

## How Long We Keep Your Personal Data

Your personal data is stored for the duration of the legitimate interest of the data administrator.

## Whom We Forward Your Personal Data

Your data is not transmitted to any third party.

## Processing Cookies

Cookies are pieces of information that are transferred from a website to a user's hard drive. Cookies allow the web page to memorize important information to make it easier for the user to use it. Like most websites, the Operator's website also uses cookies. The Operator, for example, uses anonymous data objects to track the total number of visitors to this site. If the User does not want to use cookies or if he/she does not want the internet browser to use cookies, he/she must select the appropriate option in his/her browser. If the User blocks all cookies, he will not be able to use some features of this website.
